

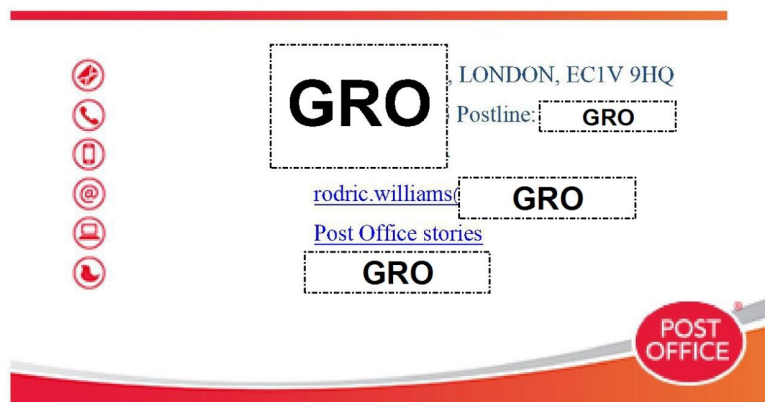

Please find attached Post Office's draft reply to the Second Sight Part 2 Report (**Part 2 Report**).

I'd be grateful for your comments on the draft reply, in particular sections 5, 7, 11,12, 18, 19 and 20. The other sections mainly concern Post Office procedure. Although all comments from Fujitsu are welcomed, if it would be quicker for you to only address the key technical areas then I suggest focussing on the sections listed above.

The draft Reply has been prepared by Post Office's lawyers and in contemplation of litigation with Applicants to the Scheme. It is subject to legal advice and litigation privilege.
