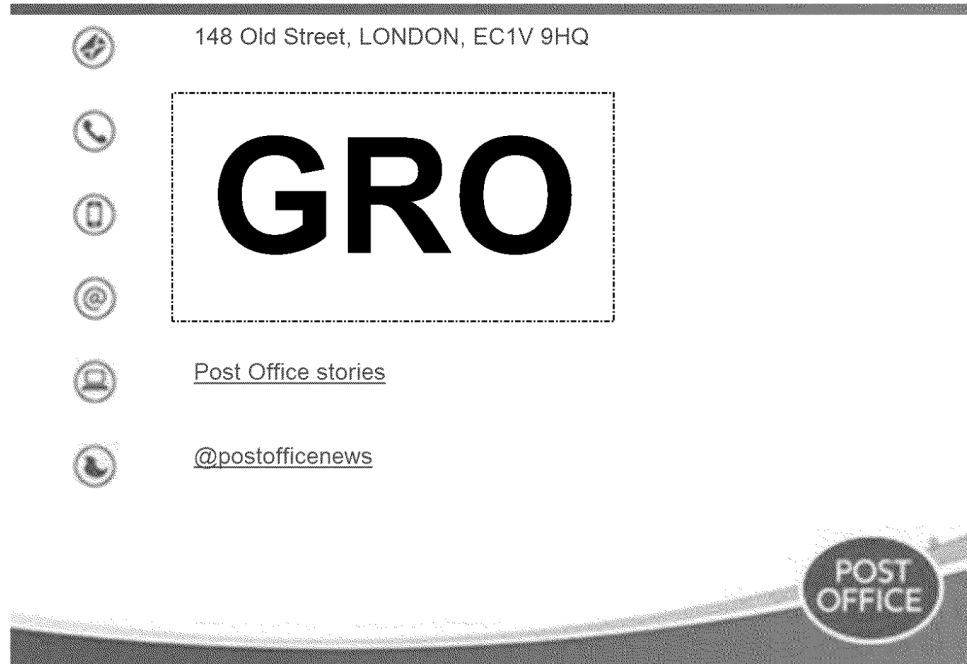
A response from Paula which explains that a full reply will go from Sir Anthony Hooper has been drafted (draft attached).
