I trust you had a good weekend.

I am not sure if this was discussed with the lawyers however we think that it might be prudent to advise your general liability Insurers QBE of this.

For no other reason than if anyone should submit a claim for stress, this could be seen as an "injury to a third party" and thus could be a claim under your Public Liability policy

It is fairly remote but by advising QBE, then they will at least not be able to decline indemnification to PO through non-disclosure or late notification.

We would of course reiterate to QBE that no claims are envisaged.
