

I've gone through the Legacy Horizon parts of your remote access notes and have the following queries on those parts:

- 1. Your comments on Coyne 2 paras 3.234-242, 3.247-248 and 3.249-265 have questions for Fujitsu which have not been answered. Also 5.423. These questions need to be answered quickly!
- 2. Paras 2.224-231 and paras 3.232-233:
 - a. You refer to OCPs for this change, but they are not in the bundle. Should they not be in the bundle (same question arises for all remote access Peaks)? Could you send over a copy of the OCPs (or OCRs?) so I can see if they demonstrate anything helpful, and if so what?
 - b. In 3.224-231, it is said that a configuration object was changed. What was the change, precisely? Given that the stock numbers in the branch accounts changed, why isn't it every bit as objectionable on Cs' case as a transaction data change? Could it not result in a false figure being inserted?
- 3. Paras 3.243-246:
 - a. You refer to two OCRs but they are not in the bundle. Should they not be in the bundle (same question arises for all remote access Peaks)? Could you send over a copy of the OCRs so I can see if they demonstrate anything helpful, and if so what?
- 3. Paras 3.247-248:
 - a. Does the TIP Transaction Repair User Guide say anything helpful? Is it in the trial bundles? Should it be?
- 4. Paras 3.249-262:
 - a. What was actually proposed here? Which counters would have been deleted and which counters' data would have been replaced?
 - b. What was the alternative solution that was adopted.
 - c. Why did the peak say "closing as insufficient evidence"?
 - d. The peak refers to problems with the OTI. What is the OTI and why would problems with the OTI have caused the peak to be cloned?
- 5. Your comment on 5.424 refers to Gareth Jenkins' comments. Can they please be set out in this note?
