
#### However:

- I understand that the ability to do this is on the basis that the audit data migration strategy is accepted (referred to in the ROM as 'Change to Audit Data Migration Strategy; acceptance of new Storage (Fujitsu CSHE) to store new Audit data as early as possible, ahead of completion of copying historic data from old storage to new (which will also take longer)') and that you are proceeding with this project with the agreement of Chris Aujard. Could you please resend him the email that you sent him setting out the details of this project.
- I understand that Fujitsu have not provided us with an exact timescale within which they can actually start the suspension of data purging but estimate that this can start no later than the back end of May. We must have some indication of when that might happen before we finally sign this off if there is a danger that there will be slippage on this then we should not proceed. Is there any guarantee about the timescales, and, what is the risk that the data migration strategy is delayed.

But subject to that, good to go asap.


