Ian is contacting Janet Walker re the latter. As yet we have only NINE cases confirmed from Janet (Caroline JACK; Gareth & Tracy ETHERIDGE; Kevin BARRON; Jenny O'DELL; Jo HAMILTON; John DICKSON; Terence WALTERS; Tim BRENTNALL; and Tracey Ann MERRITT). Janet did show, on her latest spreadsheet, a further THREE cases that are "Awaiting" (presumably where she is waiting for confirmation, from the SPM and the constituent's MP, approval to submit the case to us for inclusion in the sample). Also (of course) we as yet have no cases submitted by the JFSA. I do have some matters that I'd like to discuss with you on the Caroline JACK case when you have a moment.
