#### NOTE FOR CALL WITH JAMES ARBUTHNOT - 18 MARCH

#### Summary

- You are speaking to James Arbuthnot today in advance of your meeting with MPs on 24 March. The call is scheduled for 1330. We have discussed the handling of this call with Martin and Mark and think that this call may provide an opportunity to delay or cancel the MPs meeting.
- 2. If you do delay the meeting we think you may want to offer two things to James:
  - An update note from Post Office on the Scheme that he could circulate to MPs.
  - Potentially a further meeting with you ideally over dinner to both keep him in the loop and more importantly to build bridges in advance of any decision on the Linklaters work.
- 3. We face a number of challenges to make a success of the meeting:
- Second Sight contacted James' office yesterday to raise concerns about what they
  can cover in the meeting. They feel they cannot, and should not, speak on behalf of
  the Working Group. However, they can offer their perspective on the investigations.
  Ian Henderson has informed James' office that he understands that it would be
  inappropriate to go into details given that the investigations are still works in
  progress, and that gesturing towards any conclusions at this stage would not be
  wise.
- Content we are similarly constrained in what we can say at the moment given Tony Hooper's clear steer to keep Working Group matters confidential at this stage.
- Tony Hooper commented at the last face to face Working Group that he felt MPs needed to be patient and he would, we feel, give short shrift to any briefing to MPs that cut across the Working Group's role.
- Potential changes to the Scheme Given this morning's meeting with Linklaters
  there is also a risk that Post Office any changes Post Office makes could make
  things more difficult if there is a challenging decision to communicate in the coming
  months.

#### **Delaying the MPs meeting**

- Interested to get your thoughts on Second Sight's concerns about what they can cover in the meeting.
- Post Office faces similar constraints from Tony Hooper over what we can say.
- · What is the current attendance from MPs looking like?
- Wonder whether we might be better updating parliamentarians in a different way?
- I could provide a briefing note for you to circulate to all interested parties.
- I would also be happy to provide you with a private briefing on where we are
- It would be also be good to do this on a slightly informal basis perhaps over dinner?

#### **Progress of Mediation Scheme**

- We have received 150 applications for the Scheme.
- · Overall we are progressing well but the pace is slower than was originally anticipated
- Where possible we are working with the subpostmasters to resolve issues as early as possible
- We anticipate the first case reaching mediation by the end of May 2014.

### **Ground rules**

Useful to revisit ground rules set out in your email to MPs:

- 1. Individual case details not to be discussed
- 2. Avoid skewing the handling of any particular case through lobbying
- 3. Allow Working Group to administer the Scheme unimpeded the Chair has asked for patience from MPs
- Media understand from your office that are not doing any media. I think this is a
  helpful approach and I intend on following your lead

# **Second Sight**

- I met with Second Sight on 24 February and this was helpful and productive.
- We are making good progress on their engagement letter. However they have been clear that they will not be able to finish their case load by end of October 2014 and we are jointly looking at options to address this.
- First case reports are in I am not involved in the individual cases but I understand
  that it remains to be seen as happened in July they have evidence to support
  assertions about Horizon based on what Subpostmasters are saying.
- Still an issue around Second Sight's focus and the extent to which they are trying to
  deliver the Scheme as fast as possible as they continue to discuss the unspecified
  "wider work" they are doing for you and MPs which is outside of the Scheme.

# Modification of the scheme

- Exploring options with Second Sight to augment the Scheme's speed to deliver outcome sooner
- No decision yet made on the way forward
