I have not commented on the draft itself as it sounded like others will be covering that, but I am coming at this very much from the point of view that the public purpose document is a step along the path towards mutualisation. As mentioned, this is going to be quite a focus for ministers going forward. Thoughts are: Publication - I take your point in the paper about not wanting the rollout of this to collide with other areas. However, ministers are keen to see momentum on this and on that basis would probably want something to come out sooner rather than later, and the Annual Accounts in June(?) might be a bit late. I suppose we could show ministers the public purpose doc once finished, and explain its belated release, but I would have thought they'd want to show progress publicly. · Monitoring - I am reasonably agnostic about whether the Board or the ARC monitors the metrics related to the public purpose. That said, it would probably send a more powerful message if it was the former rather than the latter, and if it was indeed the latter then I would expect that the ARC would onward report to the Board. • Mutualisation pledge - I initially wondered whether the documents' pledges should finish with a final bullet about POL pledging to make progress towards mutualisation. I think this would earn quite a lot of credit with ministers, buy you some breathing space, and come at minimal cost to some extent. Having heard the discussions at the Board, I still think this is true to some extent, but also accept that this is very much about the public purpose and not mutualisation per se (even though one is a prelude to the other). Nevertheless, perhaps something to gather views on? • Building relationships based on trust - we are keen that POL begins to move towards a more mutual culture before it becomes a mutual. Does this point about
