Submission title: Post Office Redress Data Publication- July

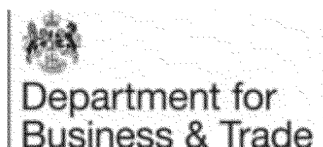
Timing: As soon as possible, to allow for publication mid-July
