Re POL contact. The last email that was sent out to MPs offered that Post office was happy to talk to individual MPs about their constituents cases. James would like to talk to someone above his constituent, and we have a couple of others who wish to do the same. Your draft email below states that individual cases cannot be talked about in a proposed individual meeting between POL and an MP – but this is not what the email that went out on 4 February stated. It read:

I would like to mention a couple of matters in advance of the meeting. The mediation scheme is running, and we must take care both to respect the privacy of individual applicants and to avoid skewing the mediation process. Individual cases will not be up for discussion, but I am sure that if any colleague wanted to seek a separate meeting with Post Office to discuss an individual case, Post Office would be happy to arrange this separately.

As it was an offer that came from your side, I assumed there would be a contact to whim I could refer MPs. Can you let me know please?

I sent an email some time back about the amendments, saying they were good. Thank you for them.

Attendance for next week - I'll pull together a list once I've sent this new draft email out, as we'll get responses.

I'll look carefully at your draft, as we need to iron out this business about MPs being able to talk to PO about their own cases.

In advance of our meeting with Post Office on 24 March. I wanted to write to update you all on progress and to emphasise some areas that we will not be able to cover in the meeting having spoken to Second Sight and the Chief Executive of Post Office this week.

I realise that some of you might want to discuss in detail the progress of cases through the Complaints and Mediation Scheme. However, we must avoid doing anything that could undermine the integrity of the Scheme, the Working Group administering the Scheme or the individual cases within it. For that reason it will not be possible to discuss individual cases and both Post Office and Second Sight have stressed to me how important this is.

Separately Post Office have offered to meet with any MPs individually to discuss areas of interest to you and I encourage you to take up this offer, but it is worth noting that Post Office will still be unable to discuss the detail of individual cases within the Scheme.
