Martin,

It is clear following our con last week with Brian Altman that week are not going to have bottomed out the possible disclosure around the "Balancing Transaction" function in the immediate future given the questions we need Fujitsu to answer. However, we cannot delay the progress of the M081 case (or indeed any other case) in the interim.

I have therefore attempted to blend our existing Remote Access/Balancing Transaction statements (principally taken from our Part Two Response) with Simon's Disclosure Note in POL's comments on Second Sight's CRR for M081 (attached), in a way which strives to be consistent with what has previously been said and what might be disclosed (based on our current knowledge) in the criminal law context.

Can you please therefore look at the attached draft response and let me know if you and/or Simon are happy with the drafting. If not, please provide your amendments.

I repeat we cannot delay releasing this response to Second Sight any longer. Please therefore come back to me during the course of tomorrow.

I have copied Andy Parsons in so that he can progress the rest of the clearance once we have received your views.

All – here's my proposal for stopping the "drift":

The current block to progressing claims through the Scheme is ensuring consistency in our statements on balancing transactions between what we:

- have already said publicly (POL's Part Two Response);
- 2. have already said in individual cases (the CRR responses);
- 3. are going to say in individual cases (in particular the pending CRR responses for M137 and M081); and
- 4. are going to say so as to comply with our continuing duty of disclosure in criminal cases.

The most sensitive point is (4). I understand Simon is pulling together a list of cases where disclosure is required, looking at what we have already said publicly (1), then draft a suitable disclosure note (4) which ideally ties into the public disclosures.

However, that might take some time during which we need to keep moving cases through the Scheme (3).

To keep the individual Scheme cases moving, I suggest Simon looks at what we have already said (1 and 2) to confirm whether or not that is sufficient for criminal disclosure purposes. If so, we will be able to provide a consistent position going forward in both the CRRs (3) and criminal disclosure (4), because both will simply be referring to the same public statement (1). In that regard, I note Dan Fawcett has advised that our CRR response for M137 as currently drafted is consistent with POL's Part Two Response.

It should be relatively easy to provide 1 and 2 to Simon, as as far as I am aware (but please correct me if I'm wrong) we have only publicly discussed balancing transactions in our Part Two Response, and used stock language when commenting on individual CRRs (which language has already been the subject of a discussion between BD, CK and POL). Andy - can you have someone pull together the balancing transaction language we have used to date asap?

Simon/Martin – can you let me know whether you are happy with this approach?
