

		about the pension and allowance discrepancies that have been found using
		these date stamps. You were telling us that you've had a few problems at
		home and that. While I understand that you've been working under
		pressure, you gave us an explanation then and you tell us you work quite
		quickly, is there any reason why all these discrepancies are only appearing
		in pension and allowances when none of your other work?
	LB	No, I've got no explanation.
	SB	It amounts to close to £1000 in a few weeks, it's getting a little bit more
		than just being careless.
	LB	Yeh, it is.
	SB	Your balances haven't reflected.
	LB	No.
	SB	Nobody's come back to you.
	LB	No.
	SB	I don't know how much we believe that everybody's completely dishonest
		when you've overpaid them. You haven't double keyed a number
		because the numbers are different on the front on some examples.
	LB	Yeh. I haven't got it, that's all I can say. I haven't got it.
	SB	There's got to be a reason for it, you can't just lose £1000
	LB	What if I'm serving them and say I pay off the docket and I'm giving it
		somewhere else short in the day and not knowing or I know I'm like
		clutching at straws here.

	LB	Several, I don't know. I really don't know.
	SB	They're all mistakes all centred around the pensions, you're not making
		mistakes anywhere else. I mean it's not you're duty's not just about
		paying out pension and allowances. You've got a number of transactions
		to perform but all your mistakesand they're very convenient, £100 or
		£200 with a different number in the pensions.
	LB	I don't know what to say, I haven't got it, I haven't got it. I don't want to
		lose my job if I'm crap or even if you think I'm robbing. I don't want to
		lose my job.
	SB	Is there any reason why the Post Office should continue to employ you,
		giving £1000 away in a few short weeks.
	LB	I don't want to lose my job. I love my job. I thought I was good at my
		job.
	SB	We'll be making further checks, what if we find even more. When do we
		draw the line between it being careless and deliberate?
	LB	I don't know.
	AG	See this started simply because someone in Chesterfield decided to ask for
		the dockets for Heighton to be checked for week 41. 18,000 post offices,
		we can't check every pension claim for every office every week so there's
		a certain percentage checked and Heighton came out of the hat for week
		41 and these discrepancies were found, not major discrepancies, there's
		£139.70, there's things like 20p disallowed which means something has
		been overclaimed by 20p, there's another one £20 disallowed, I mean
		that's virtually nothing. 50p allowed so someone has made a mistake the
		wrong way there, they've not paid out £15.50, or they've paid out £15.50

		and claimed it as £15 so that's 50p allowed. Then we've got another £20
		disallowed but then we've got one order valued £179.05 has been claimed
		but it's not there, it's missing completely.

	AG	No. And there's another one, group 14, there's 3 at £79.05 claimed and
		there's 4 received. Now, that's probably because what they've done there
		is they've worded it the other way round. What they've said is there's a
		docket for £79.05 that hasn't been claimed but it's a docket for £179.05
		which is isn't there which has been claimed so in effect that probably is
		you if we have a look at that one. So to carry on from that, week 41 found
		these errors so a further 4 weeks were checked and the same sort of errors
		every week.
	LB	Yeh.
	AG	So then we've had a look at the pouch each week when it's left here and
		there's a lot to go through and we've found further mistakes so we
		haven't asked for Lisahally to make any further checks in between yet
		because the matter's quite serious, we're losing £100, £200, £300 a week,
		if I just check that one in fact, because we have the listings here. Right,
		we've got week 41 which is there, that's 42. And they're talking about a
		group 14. It's that one there isn't it? Yeh. I'm just going to show you
		that one, Steve's gonna give that an initial as well and a number.

	AG	There you go, that's £100, exactly the same as the others. So if we just
		look at these, the £100 there plus another £100 is £200 plus that one is

		press the right buttons. You're doing it on all the other transactions.
		Your giros, your giro impayments, your out payments, green giros,
		telephone bills. You said you balanced almost to the penny.
	LB	I didn't say that.

		at least 4 occasions each week if you're working the same way each day.
	AG	You'd be making mistakes on your pensions all the while wouldn't you.
		You'd be £100 over or £100 short, £50 over because you're working so
		quickly the keyboard is so I don't know, so difficult to operate when
		you're paying a pension out. Not you then. You've not stolen any
		money?
	LB	I haven't got it, no.
	AG	OK.
