

Afternoon,

I have spoken to this outlet today regarding the high levels of cash holdings. This outlet pays out £2500 on average per week and has been holding in excess of £20k since the beginning of the year. I have asked that the Postmistress returns at least £25k on Wednesday, I do have concerns however as to whether the cash is actually there and believe there could be a risk of loss. I have spoken to CIT and advised them that the office will be returning £25k. If possible I feel it would be prudent to physically check to see if the funds are there before contacting audits if the cash is not returned on Wednesday,
