Ladies and Gentlemen,

I attended a procedural hearing yesterday.

- 1. Mr Castleton's application to adjourn the trial was itself adjourned to Tuesday next week. By way of update, Mr Castleton has now disinstructed his legal team and is acting in person. He is going to seek an adjournment of the trial and there will be a procedural hearing on Monday 27 November to consider this amongst other matters. We will oppose any adjournment.
