Thank you for doing the meeting and the note. It makes me sad but doesn't surprise me.

There are two alerts for me - the first is your point about the bland Board paper: I have just seen a bland update from Susan on this week's work, which I have immediately sent on to Chris, with some concerns about lack of progress (some issues - SS costs and working party process - remaining the same as when I left last Wednesday/Thurs) and no risks flagged at all. for example, there is no colour on the fact that our external lawyers have issued disclosures on 9 cases, up from 2 a week ago.

The second alert is how much Susan sees as 'beyond her control'. One for my full return.

I will keep close to this and to Chris, who also was briefed to deal with the SS costs issue. (Heartening he is rising to the challenge.)
