If this had been done then all should be over and done with by now, only taking four and a half years in my case.

Well, it hasn 't, by 8th May, Post Office Ltd., already had been given two extensions, yes two, and the working group weren' t going to give them any more!!! Ha!Ha! My papers might be going in 2nd July, so how many more extensions were they allowed? As I said previously, it isn' t as if we have sprung this on them, they knew about my case since April 2013, and before that when it all went wrong which was 2009.

Sir Anthony Hooper , Chair of the Working Group, has allowed Post Office Ltd., to defer my case, and others, no end of times, I really do question just how independent he is?

If my case has taken this length of time, and let me tell you I am absolutely so fed up, you cannot imagine what my life has been like these five years, you have no idea, the complete and utter frustration, anxiety, anger and some very dark thoughts. I can relate somewhat to Martin, I don 't know his case, I don 't know how long he has been fighting for justice, I am crying as I type this, because it is just so sad what you and Post Office Ltd., has made Martin do, and the effect that this has had on so many people, by people who will not take responsibility, and hold their hands up and say 'YES, HORIZON SYSTEM WAS/IS WRONG, AND WE HAVE MADE A TERRIBLE MISTAKE, SO LETS RECTIFY IT, AND PUT YOU OUT OF YOUR ANGUISH, AND MOVE FORWARD AND LET YOU LIVE YOUR LIVES IN A RIGHT A PROPER WAY. IT WILL ALL BE DONE AND DUSTED BY THE END OF AUGUST 2014 '

Mr Cameron, please look at this, don 't just pass it on, for it to get put back into the hands of Post Office Ltd etc., especially for Martin 's family please, and all the families that have had to endure years of Post Office Ltd., intimidation, incompetence and negligence.
