Jane – these are the two FOI responses to the BBC – one from last October providing figures for past five years and

one more recent one which gives the 14/15 figure of one prosecution and the context for the drop in the numbers, which is essentially that we behaved appropriately, there was an investigation into Horizon etc.

It would, as discussed, be very difficult to go back many years ago because the information was held differently and under the central RM legal function (it may not now even exist under retention policies). I think we have had to refuse some FOIs for older information in the past on a cost or other basis because of the difficulties.
