
As just discussed, I've given you the briefing pack for tonight's adjournment debate on the Post Office/Horizon issue. Andrew Bridgen MP is down to lead and is planning to call for a judicial enquiry (he has already done so in this Sunday's Express), alleging that Post Office has failed to give justice to a small number of subpostmasters who raised complaints about the system. There have been two independent reviews on this matter, the most recent being in April, which said that there were no problems with the Horizon System itself. The focus has now shifted away from criticising the I.T system and is now on the Post Office's handling of the situation, mostly around its approach to prosecutions. The fact remains that there is no evidence that any individual's conviction is unsafe, and there are legal avenues (appeal, or the Criminal Cases Review Commission) if people feel there have been miscarriages of justice. Officials recommend that we resist calls for a judicial enquiry and maintain that this matter is independent of Government (we are the shareholder of Post Office, not the manager).

We've also heard that **he is down to ask a question at PMQs. Given the recent coverage**, and the fact that there will be a debate this evening where the Government will resist his calls for a judicial enquiry, he may want to **press the PM on Wednesday**. Officials want to make sure that we're joined up, so we don't resist this evening, only for the PM to accept or soften the position on Wednesday.
