Thank you for your time on the call yesterday. Please find below a summary of the actions:

### Known Error Log

FJ to confirm that the NDAs in place are broad enough to cover disclosure of the KEL to the Cs solicitors and Jason Coyne.

FJ to consider and discuss with WBD any concerns about whether a waiver / confirmation is required from Post Office's Information Security team to enable FJ to disclose the KEL.

WBD and Freeths to discuss how the KEL is placed into the Court record and protections to be put in place.

FJ to confirm the number of historic KEL entries and provide time and costs estimates for extracting all entries.

### Unfiltered transaction and event data

FJ to confirm time and costs estimates for extracting 400 months of unfiltered transaction data.

WBD and FJ to discuss the other data which is available in Horizon.

It would be appreciated if 1, 2, 4 & 5 could be finalised during the course of this week so as we progress the discussions with the Claimants.
