Janet: As mentioned, I had three 'spare' places in the 47 population number. That was because of the inclusion of the two POL-supplied names and the double-counting of the Burgess-Boyde and Ray Clarence cases that were, in truth, only one case.

Frankly, after writing my 21st May email to Simon (see attached), I'd (perhaps wrongly) assumed that there might have been a bit of a mess-up in one or more MPs' offices (as evidenced in Gail Ward's email to Tessa Munt) and I wanted to try to cut you all some slack to cover that, and perhaps also to include another one or two of the JFSA referrals that we'd pretty ruthlessly sieved. Looks like POL's caught me out!

In any event, given Tessa's enthusiasm, I'd very much like to include that Gail Ward case. Obviously, if we drop all four of those late-arriving cases (including Gail Ward; Steve &

Megan Robinson; Rubbina Shaheen; and Doreen McQuilliam) out of the initial sample, we'd then be down to 43... or back to 45 if we include back in the (already partially reviewed) Gill Taylor and Jane Brewer cases submitted directly by POL without MP involvement.

Sorry about the (albeit well-intentioned) confusion.

I'll wait to hear from you before responding to Simon.
