Thanks for the clarification. I had not understood that that related to a specific case, I thought that was a general statement. If I am required to go to court for that, I think I need to have some more background on the specific case and exactly what is being alleged. However, please note that if I am required to do anything further on this, some commercial arrangements will need to be made to cover my time and costs since I am not covered by the normal Security Service that POL pay for.
