The counter problem which caused the first issue has been corrected by inserting a message into the messagestore, for equal but opposite values/quantities, as agreed with POL (OCP 17510). As a result of this corrective action, the net effect on POLFS is zero, and POLFS figures are in line with the branch. POLMIS received both the original message and the corrective message. Once the problem was corrected, there should have been no impact on the branch. However it has been noted that the stock unit BDC had a loss of \$1000, which was generated after the correction was made. We have already notified Gary Blackburn at POL (email attached). This appears to be a genuine loss at the branch, not a consequence of the problem or correction. When reconciliation is complete, please return the call to SSC so we can pass it on to development. The line was missing some AdditionalData so it wasn't harvested properly, but the main problem was the lack of settlement. POL authorised us to insert an equal but opposite message, to prevent a discrepancy (in theory anyway) and to avoid problems on POLFS. Please note that this is exceptional and must not be seen as a convenient avoidance in place of a fix.

Subsequent investigations showed that a second packed pouch barcode had been scanned, before the receipt for the first had finished processing. See the audit log / messages on counter 7 26th Nov at 12:43 / 12:44.

PC0147357 is already with development for what I think is a similar problem - Mode reverts to what it was prior to RISP. Please also see update on that call.
