I know that colleagues from Post Office will be talking to yours about the judgment but wanted to flag it to you personally.

The judgment is long and detailed and makes strong criticisms of Post Office, including of behaviours. We are taking these criticisms very seriously and taking action as necessary.

It is important to underline that the judgment does not affect the products and services we provide for our millions of customers through our network of 11,500 Post Office branches. It is about how we work with our postmasters and the contracts that underpin the relationships.

We will be taking a number of immediate steps in relation to the judgment, including accelerating action to investigate problems brought to us by postmasters and stepping up our ongoing drive to improve training and

support.

I hope this is helpful: I know your teams will be updated in more detail but I did want to flag this to you, particularly as it is likely to receive media coverage. If you would like a call or meeting please let me know.
