In relation to your questions;

The very first LEA letter (attached dated Dec 2015) was for Security Managers to pass to the OIC of any case they were involved with. Unfortunately there was no definitive list of who / which cases these were sent to. There may be entries of the case log but to trawl through every single case log would be a mammoth task.

The October LEA letter (attached) was again for SMs to pass to the OIC in cases they were dealing with. Again there was no central log but would be on the case log which would be a mammoth task to sift through.

On both of these occasions the letter would not have been sent to any CPS offices, only to cases being dealt with as liaison (more than likely Police)

Also attached are the addresses of the CPS offices the new LEA letter was sent. The letters only differed as they contained the address of the CPS office, the body of the letter was the same to all CPS offices.

As well as my query about "hidden columns" on your COH spreadsheet – could you also <u>urgently</u> respond to my questions below on all three different Horizon Update letters?

We **urgently** need to understand the origins and distribution of the version of the Horizon update letter which was the pre-curser to the October letter and likewise for the October and then December update letters: I attach copies of all three I have come across for ease of reference: obviously I know that Legal created the letters in October and December, but we very urgently need from you a clear explanation of:

- 1. The date of creation and circulation of the attached "pre-curser" letter "LEA Disclosure Letter.docx"— when was this letter first prepared and deployed by Security? was this letter sent out to all CPS Area Offices in the past? If so, when? Or was this letter used only on a case by case basis? If so, from what date onwards and do you have copies/a record of in which cases it was provided to the CPS and/or the Police?
- 2. The October update letter "Disclosure for CPS 21 October 19": was this letter sent out to all CPS Area Offices in October 2019 and/or was this letter only sent on a case by case basis to known ongoing cases? Can we have copies and a record of in which cases it was provided to the CPS/Police and when from October onwards?
- 3. The December update letter "[Draft] Letter to Prosecutors clean final copy.docx": confirmation this letter was indeed sent to all CPS Area Offices (including NI and Scotland) in December 2019 and copies of those letters; also confirmation, that this letter was also sent out to individual CPS/Police in known ongoing prosecutions; and again copies of those individual letters as sent.

The priority is to have a better understanding of the scope to circulation of each of these letters please urgently, even if getting the copies as sent together will take some time – can you please respond on this aspect ASAP by way of general explanations to the above even if copy letters will follow along later?
