SUMMARY OF WORK:

The purpose of this CT is to extend the suspension of the Audit and related Service Incident data purging activity (the arrangement for which ended on the 31st August 2015) until the 31st March 2017. Data purging may recommence should Post Office Ltd not agree to these Commercial Terms.

RELATED WORK PACKAGE DESCRIPTION:

(the "WORK PACKAGE")

Post Office Ltd, via Change Request DM0027689v0.1, have stated that the existing arrangement for Fujitsu to suspend data purging ended on the 31st August 2015. The arrangement was put in place in May 2014 as part of the Branch Support Programme (the programme closed in March 2015), and Post Office Ltd have a requirement to continue with the suspension through to the 31st March 2017.

Fujitsu currently have a tactical fix in place to stop the daily data purging job from running, and these Commercial Terms (CT) are to provide cover to extend that tactical fix through to the 31st March 2017.

The charges in this CT cover the effort involved in extending the existing tactical fix only.

Fujitsu would like to bring to the attention of Post Office Ltd that an alternative more secure solution is available, with the implementation of 'Eternus Dataguard'. This solution would be a permanent one to remove the job from the daily schedule, and to introduce 'Eternus Dataguard' onto existing records. This will provide additional security, ensuring that the records cannot be deleted before they are due to expire. It should be noted though that the Eternus Dataguard solution does not form part of this response, however Post Office Ltd are welcome to request this via an additional CR.
