Following discussions with Sally Berlin, the CCRC Director of Casework, we think that perhaps it may be useful to arrange a meeting between CCRC and POL so that we can better establish the issues and clarify the level of CCRC involvement. Is this something that you would be amenable to?

Secondly, we have now started to receive applications from individuals who may be affected by any Horizon issues. As is standard practice, the Commission will send out a section 17 request to any prosecuting authority for information and the preservation of material relating to an applicant.
