The first attachment to Mandy Talbot's email is the only paperwork that she has been able to retrieve re Eleanor Nixon.

I think the 3 documents in the first attachment should be disclosed, pursuant to the Defence "Nixon request", with the explanation that it is the only documentation that can been located which appears to be linked to Mrs Nixon.

The deficiency in the documents is a small fraction of the £20,000 referred to in Mrs Nixon's statement. I wonder whether Mrs Nixon is exaggerating. Please could John make some further enquiries with the relevant contract managers. I imagine they may say that they would have remembered a £20,000 loss which turned out simply to be a keying error.
