I'm concerned about the accusatory overall style, but perhaps that is due to the adversarial environment of the legal system. There is also some material that seems totally irrelevant to this case and a number of suppositions / hypotheses which do not appear to be justified and seem designed to plant doubts.

I'm happy to go through the comments with you next week and will also provide an update when I re-analyse the Transaction Corrections which I
