Jane,

I received an electronic version of the Defence Expert's report this morning.

I have gone through it and made some comments (using word revisions) based purely on the statements in the report which you may find of use.

In summary, I agree with his conclusions.

Penny has also passed me ARQ data from 10/2/10 to 12/11/10 (which I think is what the Defence has analysed and also 1/7/09 to 9/2/10.

I will have a look at that data and see if I can come up with an analysis of Cash Declarations and Cash Movements which I can then use to check the detailed examples in the report. However I am unlikely to come up with anything that contradicts the basic conclusion which is:

1. The money appears to be missing at the Audit
2. The cash control in the branch is abysmal
3. No real indication of when money was taken or by whom

Is there anything specifically you want me to look for?
