I gather Hugh thought that we ought to include employment claims in the significant litigation report and Rodric has obliged. I agree with the principle but am a little worried by the detail in this report as, clearly, this is sensitive personal data and I think the Board would prefer to deal at the high level of Company liabilities rather than individual cases. Do you think it would be acceptable simply to add a bit onto the existing litigation report instead, along the lines of:

Employment litigation claims in progress: 3 (2 unfair dismissal, 1 sex and race discrimination and victimisation).
Maximum potential liability to Post Office: £175k (or whatever it is – I added £100 + £23 + a guess but Rodric would presumably give me a guesstimate)
Special circumstances: None (ie the claims are not very high profile or break new ground in terms of legal procedure or policy changes for Post Office).
