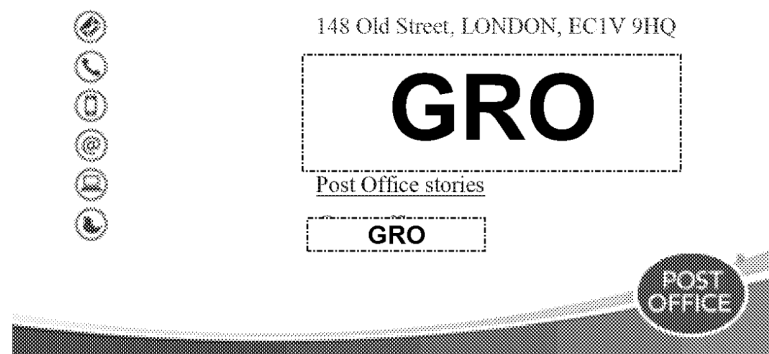

Thanks for this. What evidence will you be putting forward to support the serious suggestion that there "might" have been miscarriages of justice? You will be aware that should there be evidence of that Post Office has a legal duty to disclose that evidence. It therefore follows that to make such a serious allegation there must also be some evidence to support it, and if so I would urge you to please let me know what it is so that we could discharge our responsibilities.

Given that this appears to be the main thrust of your programme I think it very important that you provide us as soon as possible with evidence to support the suggestion, particularly as we are not being accommodated to appear in your film. Hi Jane

Thanks for this. If everything is laid out in your communications of last week, there is no real substance to any of the serious allegations you seem to be making, or at least not that you have shared with us.

Please therefore can you let me know ASAP what your central allegation - the reason for this second film in a week - will be?

Although we have concerns as to the basis for any of the allegations you seem to be making, as I said yesterday, I have particular concerns about the comments of Mr Patel QC. He seems to be speculating on a very serious matter (alleged miscarriages of justice) and without any real basis, but in such a way that it is likely to be very damaging to Post Office and likely to cause serious harm.

This in itself is an extremely serious allegation around which to speculate in the absence of any evidence. It is hard to see how we could adequately respond to that in a sofa slot. We have offered you a pre-recorded interview but you have not been prepared to accommodate this.
