Hi both

Paula wants a meeting with Tony Hooper to discuss progress on the Mediation Scheme and the Working Group early w/c 24th Feb. Chris A also wants a meeting with Tony next week about some of the cases in the scheme. Andy Parsons is setting up the latter meeting but it makes sense that if Tony is coming in we try to do the two meeting consecutively.

Would it be possible for you both to confer (as I cannot access either diary) to let me have Paula and Chris' availability on Monday or Tuesday (the meetings are urgent so I think they would both be prepared to move meetings where possible to accommodate Tony).
