Mandy,

The case is ready to be listed for hearing. Replies to particulars have been served. Discovery has been provided.

I have had discussions with McAlerney's solicitor. They are still making some noises re the Horizon system but I am not getting the impression that they expect their arguments to bring them very far.

McAlerney is in financial difficulty. She is trying to sell land, upon which the bank has a charge, in order to decrease her overall liabilities to the bank. It has been implied that if she can do that then she may be able to look at an installment plan. The land has planning permission and there is some prospect of an early completion.

Before listing for hearing and having to gather together the relevant witnesses I have suggested to her solicitor that she consent to Judgment. He was not adverse to that proposal and was to take instructions and revert.

The deadline is w/c 20th Dec 2010.

I'm conscious that if the defendant is adjudicated bankrupt then the likelihood of an unsecured creditor recovering in full is minimal. Similarly I'm trying to minimise preparation costs pending the possible implementation of settlement terms which may be attractive to POL

If there are no proposals by w/c 20th Dec I'll fix the case for hearing.
