COUNT 1

STATEMENT OF OFFENCE

FALSE ACCOUNTING Contrary to Section 17(1)(a) of the Theft Act 1968

PARTICULARS OF OFFENCE

JULIAN WILSON on or about the 16<sup>th</sup> day of May 2007 dishonestly and with a view to gain for himself falsified an account required for an accounting purpose namely the Final Branch Trading Account for Astwood Bank Post Office for the period ending 16<sup>th</sup> May 2007 by making an entry therein purporting to show that the amount of cash in hand was greater than the true figure

COUNT 2

STATEMENT OF OFFENCE

FALSE ACCOUNTING Contrary to Section 17(1)(a) of the Theft Act 1968

PARTICULARS OF OFFENCE

JULIAN WILSON on or about the 10<sup>th</sup> day of October 2007 dishonestly and with a view to gain for himself falsified an account required for an accounting purpose namely the Final Branch Trading Account for Astwood Bank Post Office for the period ending 10<sup>th</sup> October 2007 by making an entry therein purporting to show that the amount of cash in hand was greater than the true figure

COUNT 3

STATEMENT OF OFFENCE

FALSE ACCOUNTING Contrary to Section 17(1)(a) of the Theft Act 1968

PARTICULARS OF OFFENCE

JULIAN WILSON on or about the 12<sup>th</sup> day of December 2007 dishonestly and with a view to gain for himself falsified an account required for an accounting purpose namely the Final Branch Trading Account for Astwood Bank Post Office for the period ending 12<sup>th</sup> December 2007 by making an entry therein purporting to show that the amount of cash in hand was greater than the true figure

COUNT 4

STATEMENT OF OFFENCE

FALSE ACCOUNTING Contrary to Section 17(1)(a) of the Theft Act 1968

PARTICULARS OF OFFENCE

JULIAN WILSON on or about the 9<sup>th</sup> day of January 2008 dishonestly and with a view to gain for himself falsified an account required for an accounting purpose namely the Final Branch Trading Account for Astwood Bank Post Office for the period ending 9<sup>th</sup> January 2008 by making an entry therein purporting to show that the amount of cash in hand was greater than the true figure

COUNT 5

STATEMENT OF OFFENCE

FALSE ACCOUNTING Contrary to Section 17(1)(a) of the Theft Act 1968

PARTICULARS OF OFFENCE

JULIAN WILSON on or about the 21<sup>st</sup> day of May 2008 dishonestly and with a view to gain for himself falsified an account required for an accounting purpose namely the Final Branch Trading Account for Astwood Bank Post Office for the period ending 21<sup>st</sup> May 2008 by making an entry therein purporting to show that the amount of cash in hand was greater than the true figure

COUNT 6

STATEMENT OF OFFENCE

FALSE ACCOUNTING Contrary to Section 17(1)(a) of the Theft Act 1968

PARTICULARS OF OFFENCE

JULIAN WILSON on or about the 20<sup>th</sup> day of August 2008 dishonestly and with a view to gain for himself falsified an account required for an accounting purpose namely the Final Branch Trading Account for Astwood Bank Post Office for the period ending 20<sup>th</sup> day of August 2008 by making an entry therein purporting to show that the amount of cash in hand was greater than the true figure

COUNT 7

STATEMENT OF OFFENCE

FALSE ACCOUNTING Contrary to Section 17(1)(a) of the Theft Act 1968

PARTICULARS OF OFFENCE

JULIAN WILSON on or about the 11<sup>th</sup> day of September 2008 dishonestly and with a view to gain for himself falsified an account required for an accounting purpose namely the Final Branch Trading Account for Astwood Bank Post Office for the period ending 11<sup>th</sup> September 2008 by making an entry therein purporting to show that the amount of cash in hand was greater than the true figure
