Fujitsu have advised us that they can make the PEAK and TFS systems available for inspection (by way of a demonstration by the relevant Subject Matter Experts) on 28 June. Fujitsu's view is that two hours for each system should be sufficient and they are therefore reluctant to tie up the relevant resource for two consecutive days. They have suggested that we proceed on the basis of a one day session, with the option of arranging a second day if that proves necessary.


