SUBJECT: Contractual Position with ICL Fathway

- 1. As you know, we have been seeking to protect the legal interests of sponsors throughout the re-planning period with ICL Pathway. As you may be aware, ICL Fathway have failed to complete the Operational Trial by the contracted date of 21 November 1997.
- 2. In anticipation of this breach I have had discussions with the Programme lawyers and agreed the way forward with George McCorkell and Paul Rich. In a nutshell the agreed course of action is to write to ICL Pathway, informing them of this breach, at the earliest opportunity.
- 3. We are therefore issuing a letter informing them of this breach of contract but reserving our position on rights and remedies resulting from this breach. It is our intention, of course, to continue discussions on re-planning the Way forward. However, should we wish to use the breach at any point in the future, including to terminate the contract, not to have issued the notification now would be deemed as a waiver of our rights and remedies.
