Solicitor Service Improvements	Develop standard check list of information provided to Solicitors. (i.e. To ensure Solicitors can see upfront whether everything they require has been provided).	Mandy Talbot
Ownership Matrix	Develop a RACI matrix for e2e debt processes. (i.e. Accountabilities, Responsibilities, Consulted and Informed). A RACI matrix describes the participation by various roles in completing tasks or deliverables for a project or business process. It is especially useful in clarifying roles and responsibilities in cross-functional departmental projects and processes.	Alison Bolsover
Legal Skills	Determine the legal skills required by Product and Branch Accounting for managing debt recovery processes.	Alison Bolsover
External Crime Reporting	Investigate cost / benefits of having access to 'Suspicious Activity Reports' via the Serious Organised Crime Agency. (i.e. To help detect criminal activity earlier in the debt process).	Andy Hayward
