Dear Alysa

In answering Jo's question it may be useful to clarify what is meant by the term 'case report' and the report that Second Sight has produced that was leaked to some media outlets.

As part of the Working Group process, both Second Sight and POL produce 'case reports' on the submissions made by individual applicants. These case reports are specific to the individuals and are intended to aid the mediator in the event that the Working Group recommends that the case go to mediation. Tony Hooper's role as Chair of the Working Group is to ensure that applicants' cases can progress through the scheme as smoothly and quickly as possible. Part of this is to ensure that individual cases are well researched, appropriately evidenced and objective before they are put to the Working Group for consideration, and this has, on occasion led to him requesting that some case reports be re-written (please note that this information is strictly confidential and must not be released as it would risk prejudicing the operation of the Working Group).

The report that Richard's email referred to has become known as a "thematic report" and the intention had been that it was produced as a generic reference document for use during the mediation process. To be clear, although the Working Group can recommend a case for mediation, it plays no role in that mediation, which is between the applicant and the Post Office as the two involved parties. There is no role for Tony Hooper in the mediation process either. ShEx officials understand that as the mediation process does not involve the Working Group, Tony Hooper has taken the view that the Thematic Report is outside of his remit. The fact that he didn't ask for the thematic report to be re-written does not suggest that he found it credible.

Given the high number of objections that POL has flagged about Second Sight's thematic report (and indeed the JFSA was critical of aspects of the thematic report too), it is perhaps unlikely that any report would satisfy all parties. Instead, POL is producing its own report to inform the mediation process that will sit alongside the Second Sight report. It is our understanding that the JFSA are also producing a briefing note as they too disagreed with elements of the Second Sight report. It is the role of the independent mediator to use the available information to inform the mediation process – not the Working Group.

It is not, at this point in time, appropriate to ask Tony Hooper for more details about his views on a report that is still confidential from the perspective of the Working Group.

I am very happy to discuss the above with you at any point.
