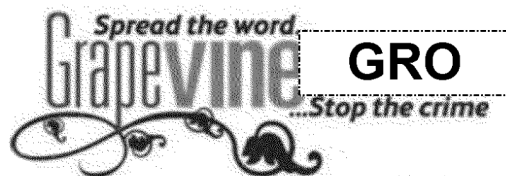
Andy; can you confirm that if required, you are able to cover Penny's evidence in case she is unable to attend.

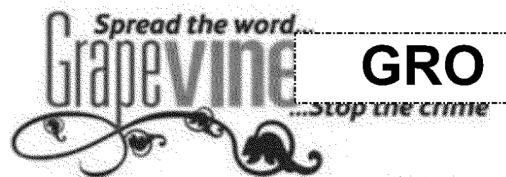
