So far I have checked and no call reference H22766041 appears to exist for 19 April 2010. I cannot find H22792410 in 24 June and therefore also checked 25 June with same result. It should be noted that H22792410 is not a valid incident range for the dates given I can therefore only assume that either the date given is incorrect or the reference is invalid. Unfortunately we are unable to search by incident so we need the correct branch code if these were not for Birkenshaw, or the correct date or reference

21/07/2010-H2572046 and 01/08/2010-T1687336 are both an invalid references as they are short a number

The only remaining alternative is to run all incidents logged at NBSC for each month of the date ranges given in the hope that they are listed some where.

I have been processing your request since 14:00 this afternoon and have yet to successfully extract a monthly report due to the volume of calls.

Without further clarification of branch code or the correct dates this request becomes considerably more complex.

I will work until the building closes at 18:30 however, it is extremely unlikely that I will be able to provide you with what you need at such short notice, due to the above.
