This is an update on progress following your meeting with James Arbuthnot and Alan Bates regarding the review of Horizon cases:

- 1. Post Office have reviewed the "immunity agreement" (drafted by JFSA) and created a revised version. (attached)
- 2. This revised version is with 2nd Sight for comment, if OK with them we will send it to JFSA.
- 3. Our hope is that this will remove the JFSA reason for not sharing cases with us.
- 4. At this time, we don't believe it necessary to publish an article in the subspace magazine to encourage more sub-postmasters to come forward:
 - a. We already have 16 cases in the review
 - b. We expect the immunity agreement will allow JFSA to share the cases they tell us they have but haven't yet shared.
 - c. We will review our position on communications to sub-postmasters after we have discussed the immunity agreement with the JFSA.

I will keep you informed as things progress.
