Ivan,

In relation to my action below, I've discussed this with our 3rd line support manager (Steve Parker) and assuming we are talking about a small number of requests for retrieving logs / data associated with the model office then this can be accommodated by raising specific calls on the Horizon Held Desk requesting the specific info required which can then be returned by email (I am assuming that there would be noting sensitive in the data). If the requests (and resulting work) is considered to be excessive we may need to come back with some sort of charging mechanism. However my initial feel was that this wouldn't be the case.

Steve has also pointed out that in the past one of his team has run a workshop on recovery and the issues associated with it. He would be happy to run this again with Second Sight, but in that case there would be some chargeable costs.

Currently I am booking my time spent on this to the Post Office Prosecution Support team and I would suggest we did the same for any such workshop.

Note of phone call @ 11:30 25 March 2013 attended by Ian Henderson, Gareth Jenkins, Ivan Swepson.

Model Office in 148 Old Street is a functionally live Post Office environment. The facility is used to pilot new Horizon releases before branch roll out and as a simulation/demonstration suite. Horizon facilities are live – transactions appear on back office systems. All transactions are logged as standard – some tailoring may be possible subject to requirements. The environment appears suitable for the tests intended by Second Sight.

Second Sight want to test a number of scenarios as though they occur in a single branch operating more than one Horizon terminal. They intend to follow a structured approach to testing so Post Office and Fujitsu are clear what tests are to be carried out. Some of the tests will involve removing power and/or network communications from Horizon terminals and possibly the Model Office router – affecting multiple terminals simultaneously. Second Sight acknowledge that power and network communication failures outside Model Office and at the Data Centre cannot be simulated in the Model Office environment.

Testing will be an iterative process. As Second Sight will need to see transaction logs between tests several visits will be scheduled at least 2 or 3 working days apart.

Second Sight require permission to video record the Horizon screen as a record of the transaction and on screen messages.

Attached below are 3 Horizon test scripts supplied by Fujitsu as examples.

Actions:

- 1. Gareth establish process and commercial arrangements for Horizon transaction logs to be recovered and emailed at close of Second Sight test days
- 2. Ivan brief Phil Jeary on approach to testing, support required, logins required. Ask Phil for Horizon Release and Maintenance Schedule and permission for Second Sight to video Horizon
- 3. Ivan arrange conference call with Second Sight and Phil Jeary to plan approach to testing in more detail
- 4. Second Sight progress test plans in preparation for conversation with Phil Jeary.

Please let me know if I have missed anything or any corrections are required.
