

Please find the list of new cases attached.

The level of information the spreadsheet contains is poor, I'm afraid. Dear Susan and Alwen,

James has come back to me with the following, which he kindly simply said pass straight on to you unedited.

"In the first document there is a "singed" rather than "signed".

In the second there is the following sentence: "If a solution cannot be reached directly between Post Office and the Subpostmaster, both parties will then be invited to attend mediation." This implies a right to mediation even if (as stated by the previous paragraph) the case review has determined the case is not suitable for mediation. I personally would include after the words "both parties" the words "in a case found suitable for mediation", but it's not a crucial point.

The third document begins "Thank you for your Application to the Initial Complaint Review and Mediation Scheme. I am pleased to confirm that your Application has been accepted." It does not make clear what "accepted" means. Accepted for what? Mediation? Consideration for suitability for mediation? Some overoptimistic sub-postmaster might even take it as suggesting the points they have made in their application letter have been agreed, and it needs to be made clear that is not what is intended.

Subject to those points, I am very happy with the way this is going, agree my quote (Susan / Alwen, see below) and have spoken to Sir Stephen Sedley who might well be interested and would be a perfect chair provided it did not take too much of his time. I haven't told him much in order not to compromise his independence, so the Post Office would need to set out clearly what was expected of him. They need to speak to his senior clerk, Glenn Hudson, in his chambers, Cloisters, GRO

The quotation you might consider dropping into the eventual announcement should read as follows, and I would be very grateful to have sight of a draft copy prior to his eventual release.

'James Arbuthnot said today, "I am very pleased indeed with the working group's proposed process. To my mind, it represents the very best chance all parties – individual SubPost Masters and Mistresses, and the Post Office – have of ensuring the best outcome for everyone. It is fair, thorough, and independent."

Many thanks, and I'll be in touch tomorrow with new cases list.
