We discussed the possibility of a catch up tomorrow as it was looking possible that we may have Second Sight report in the public domain very shortly.

Just to let you know, following the WG meeting on Friday it seems very unlikely that anything will be agreed by the Working Group before early April.

Second Sight have been asked to finalise their 'thematic report' by 26 March for consideration by the WG the following week, and to concentrate on that rather than trying to do any more individual reports at this stage.
