Yes that is the report. I'd also direct you to our written evidence to the BIS select committee and also our detailed response to the parliamentary debate held last December. Mel can send these to you.

As you know Second Sight produced its final report earlier this year. These are confidential documents concerning the individual complaints being reviewed through the scheme. However, given your interest in this matter, we will provide the report (and our response) on request on the basis that, whilst they can of course be used for background, confidentiality is preserved and the documents are not reproduced, and that the privacy of individuals is respected. Can you let me know?

I will let you know about the interview bid in relation to Paula. In the meantime, I would reiterate my offer to provide a full face to face briefing: as you say there is a lot of material on this subject and I do think that this would be beneficial.
