Finance concurrence already given to the CAF. This activity is already within the BSP business case so the CAF and one pager completes the governance requirements.

The current in-branch procedure is reliant on the user manually verifying that cheques on hand match the Horizon system. This is the problem area that the new process will address and in doing so reduce errors in that the Horizon system will automatically pull through the rem out figure rather than the user inputting the figure into Horizon..
