I have made a further amendment to the draft answer to reflect our discussion. I have also added relevant correspondence to the background material.

Alan Cook's letter to Jacqui Smith (copy now attached) does not support Pat's suggested amendment that 'POL is looking into the issues raised'. This letter and the letter to Brooks Newmark MP (also attached below as it has not copied well into the background note) make clear that subpostmasters concerns are always taken seriously and investigated (on an individual basis) and to date POL has found no case where Horizon has caused accounting errors.
